Silver Cliff, Colorado

- Drilling in the 1980's resulted in a historical pre-feasibility study that formed the decision to put the property in production, but were halted due to the restructuring of Tenneco after it was sold.
- Silver Cliff is thought to overlie a large caldera and porphyry system which increases the prospect's potential to host a number of deposits from both precious metals to base metals.
- The 2016 and 2017 drill programs confirmed high grade silver from surface for open pit mine potential and identified 12.7 million ounces of silver.

Hole K16-01 showed 837.4 g/t (26.79 oz/t)Ag over 15.24 m (50.0 ft), including an interval 6.9 m (22.6 ft) grading 1778.5 gt (56.91 oz/t)Ag.

Hole K16-04 showed 178.5 g/t (5.71oz/t) Ag over 21.34m (70.01 ft) including a 203.4g/t (6.50oz/t) Ag interval over 18.29 m (60.00 ft).
